

**RELEASE OF LIABILITY, WAIVER OF CLAIMS, AND ASSUMPTION OF RISK**

**BY SIGNING THIS DOCUMENT YOU ARE ENTERING INTO A CONTRACT WHEREIN YOU MAY BE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE**

**TO:** The Yorba Linda Ice Rink and Yorba Linda Ice Rink, LLC and the owners, officers, directors, members, agents, employees, and/or representatives of the above-listed organization (collectively referred to as "Ice Rink"):

**ASSUMPTION OF RISK:** I am aware that ice skating, ice skating lessons or instructions, ice hockey, ice hockey lessons or instructions, figure skating, and figure skating lessons, broom ball or instructions involve certain inherent risks, dangers, and hazards which can result in serious personal injury, death, or property damage. Moreover, I am aware that ice skating rinks and arenas contain certain inherent risks, dangers, and hazards which can result in serious personal injury, death, or property damage. As such, I hereby freely and voluntarily agree to assume and accept any and all known and unknown risks of personal injury, death, or property damage arising out of my utilization of the Ice Rink and/or my participation in ice skating, ice hockey, figure skating or broomball at the Ice Rink. I acknowledge that the risks of ice skating, ice hockey, and figure skating can be greatly reduced by taking lessons from a qualified instructor and using common sense.

**RELEASE AND WAIVER OF CLAIMS AGREEMENT:** In consideration of allowing me to participate in the Ice Rink's public skating, ice skating or figure skating programs, and/or hockey leagues or activities including broomball, I hereby waive, release, and discharge any and all claims for damages for death, personal injury, or property damage which I may have, or which may hereafter accrue to me, as a result of my participation in the Ice Rink's public skating, ice skating or figure skating programs, and/or hockey leagues, broomball or activities. This release is intended to discharge in advance Yorba Linda Ice Rink, LLC, and any of its subsidiaries, owners, officers, directors, members, agents, employees, and/or representatives, from and against any and all liability arising out of or connected in any way with my participation in the Ice Rink's public skating, ice skating or figure skating programs, and/or hockey leagues, broomball or activities, even though that liability may arise out of negligence, carelessness, or breach on the part of the persons or entities mentioned above.

Knowing the risks of public skating, ice skating or figure skating programs, and/or hockey leagues, broomball or activities, nevertheless, I hereby agree to release and hold harmless all of the persons or entities mentioned above who might otherwise be liable to me or my heirs, next of kin, executors, administrators, assigns, or representatives for damages.

**I HAVE READ AND UNDERSTAND THIS AGREEMENT PRIOR TO SIGNING IT AND BY SIGNING MY NAME BELOW, I FULLY UNDERSTAND, ACKNOWLEDGE, AND AGREE WITH ALL OF THE POLICIES AND TERMS CONTAINED HEREIN. I FURTHER UNDERSTAND, ACKNOWLEDGE, AND AGREE THAT BY SIGNING MY NAME BELOW, I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS, OR REPRESENTATIVES MAY HAVE AGAINST THE ICE RINK AND/OR ITS AFFILIATES, INCLUDING THE RIGHT TO SUE THE ICE RINK AND/OR ITS AFFILIATES.**
